PRODUCT DESCRIPTION:

Satin / Matte Additive is a finely graded additive for sealers and coatings that will impart gloss control and leave a Satin or a Matte finish. This product will stay suspended in solution without continuous stirring. Satin / Matte Additive can be used in most sealers and coatings where a semi – gloss (Satin) or matte finish is desired. It can be used indoors or outdoors. This material helps to impart non-slip properties, and can also be used in conjunction with Skid Resistant Additive if desired. This product only need be applied with the last top (finishing) coat.

APPLICATION

Procedure – Mix sealer or coating to proper consistency if needed. Add prescribed amount of Satin / Matte Additive and remix until properly dispersed. This is an ultra-fine powder and will require a good mixing to incorporate the material. Add slowly to the sealer or coating while stirring / mixing for best results. Apply sealer or coating as directed without over rolling. This product is fine enough that it can also be used in spray applications.

Coverage / Use – Satin / Matte Additive is added at one pound per five gallons of sealer or coating for a Satin finish. (Use 1 x 8 oz. cup (provided) for each gallon.)
For a Matte finish, add 2 pounds per 5 gallons. (Use 2 x 8 oz. cups (provided) for each gallon.)
